## Removal with Consent Order

A Fitness to Teach Panel Convener has decided to issue you with this Removal with Consent Order following a request made by you on 28 March 2022 to be removed from the GTC Scotland Register of teachers.

By signing below, I, Natasha Sturrock, registration number 116747, declare that:

**1. I have had the opportunity to seek advice from an independent legal representative on the terms and content of this consent order.**

**2. I admit the below allegation(s) in full.**

*1 Between, on or around 1 August 2017 and on or around 28 June 2019, whilst employed as a history teacher at Perth High School by Perth and Kinross Council, and during the course of her employment the Teacher did:*

*(a) In the academic year 2017/2018, fail to adequately provide evidence to demonstrate that pupils, who the Teacher stated had passed their National 5 and Higher awards for leadership, had in fact met the necessary standards.*

*(b) Provide the Teacher's colleague, Colleague 1, with National 4 history assessments, purporting to have been completed by pupils, when in fact the Teacher had completed the assessments.*

*2 The Teacher's actions at allegation 1(b). were dishonest, in that the Teacher sought to represent that the pupils had completed the work, when this was not the case.*

*3 The Teacher's actions at allegations 1(a) and 1(b) were lacking in integrity.*

*And in light of the above it is alleged that the Teacher's fitness to teach is impaired and she is unfit to teach, as a result of breaching Parts 1.4, 1.5, 1.6, and 2.3 of the General Teaching Council for Scotland's Code of Professionalism and Conduct 2012.*

**3. I waive my right to further adjudication proceedings.**

**4. I agree to the imposition of the below disposal order:**

### **Removal**

I understand that my name will be removed from the GTC Scotland Register and that I will be prohibited from applying for restoration to that Register for an aggregated period of 2 years from the date of my name being removed from the Register of Teachers.

**5. I understand that the content of this Order will be made available to the public unless a Fitness to Teach Panel Convener has decided that all or any part of it should be redacted.**
