Removal with Consent Order

A Fitness to Teach Panel has decided to issue you with this Removal with Consent Order following the Panel Consideration dated 24 June 2022.

The reason for the Panel's decision is set out in a decision annex.

By signing below, I, Teacher E, registration number [REDACTED] declare that:

1. I have had the opportunity to seek advice from an independent legal representative on the terms and content of this consent order.

2. I admit the below allegation(s) in full.

1 On [REDACTED] at [REDACTED] Court, the Teacher was convicted of the following offences:

(a) On [REDACTED] at [REDACTED] you did record Partner A, c/o Police Service of Scotland, doing a private act with the intention of enabling yourself or another to look at the image of the said Partner A doing the act in that you did video record her whilst she was engaged in sexual activity; contrary to Section 9(1) and (4) of the Sexual Offences (Scotland) Act 2009;

(b) On [REDACTED] at [REDACTED] you did disclose a video recording which showed or appeared to show Partner A, your partner, care of Police Services of Scotland in an intimate situation and which had not previously been disclosed to the public at large, or any of the public, by her or with her consent, in that you sent the said video recording to Partner B, also your partner, and in doing so you intended to cause her, or you were reckless as to whether she would be caused, fear, alarm or distress; contrary to Section 2(1) of the Abusive Behaviour and Sexual Harm (Scotland) Act 2016

Teacher E was subsequently sentenced on [REDACTED] with a Community Payback Order in the form of a supervision period of 3 years, and was placed on the Sex Offenders Register from [REDACTED]

In light of all of the above, it is alleged that the Teacher's fitness to teach is impaired and ^{Teacher E} is unfit to teach in light of breaching parts 1.3, 1.4 and 1.6 of the GTC Scotland Code of Professionalism and Conduct 2012.

2 I waive my right to further adjudication proceedings.

3 I agree to the imposition of the below disposal order:

Removal

I understand that my name will be removed from the GTC Scotland Register and that I will be prohibited from applying for restoration to that Register for a period of 2 years from the date of my name being removed from the Register of Teachers.

4 I understand that the content of this Panel Consideration Outcome will be made available to the public unless a Fitness to Teach Panel has decided that all or any part of it should be redacted.
