### What is the purpose of this privacy notice?

GTC Scotland is committed to protecting the privacy and security of all parties participating in our Future of Registration Discussion.

As a data controller, GTC Scotland is responsible for making decisions about the means by which, and the purposes for which, we process your personal data. We are required under data protection legislation to notify you of the information contained in this Notice. It is important that you read this Notice, together with any other privacy notice we provide on specific occasions when we are collecting or processing personal data about you, so that you are aware of how and why we are using such information.

#### Changes to this privacy notice

We reserve the right to update this Notice at any time and we will provide a new privacy notice through the GTC Scotland website when we make any substantial updates. We may also notify you in other ways from time to time about the processing of your personal information.

#### How will your data be collected?

The Future of Registration Discussion involves online meetings. Each participant's name, email address and organisation details will be recorded on a spreadsheet so that we have a record of who is attending each session.

The sessions will take place online via Microsoft Teams and will be recorded. Each recording will be stored for one year. Each recording will be provided to our external researcher who will be collating and analysing the discussions to produce a report on the key findings of the discussion. The report will not include personal details of individuals participating in the sessions. The recordings will be retained as set out in the retention table below.

Microsoft Teams allows participants to see each other's names and email addresses. If cameras are switched on, participants are also visible to each other.

By participating in the online discussion, you are providing consent to the use of your personal data in line with this Notice.

# Purposes for which we will use your personal data

We consider that we may need to process some of the categories of personal data as detailed in the GTC Scotland General Privacy Notice (under the section "Category of Personal Data" we process about you) in relation to you, primarily to allow us to host the discussion and to build rapport with participants in order to have a productive discussion. In some cases, we may use your personal data to pursue legitimate interests of our own or those of third parties, but only in respect of functions which do not fall within our public authority functions.

Purposes for which we expect to process your personal data are listed in the table below, setting out the category of personal data, the lawful basis for processing and the time-period for which we will retain that data in respect of each category of individual:

# Who will have access to your information?

- Colleagues from our Leadership Support Office who will be co-ordinating attendance at the online discussion
- Our Chief Executive and Registrar and Strategic Director who will be facilitating the discussion and who will be supported by a Teaching Standards Education Officers
- Our external Researcher who will use the recordings to produce a report on the key findings of the online sessions and written responses.
- Our Policy Team who will be managing the Future of Registration Discussion.

# **Change of purpose**

We will only use your personal data for the purposes for which we collected it. We may, on occasion, need to use your data for another reason, but only where that reason is compatible with the original purpose. If we need to use your personal data for an unrelated purpose, we will notify you and we will explain the legal basis which allows us to do so. Please note that we may process your personal data without your knowledge or consent. However, be assured that we will only do this where the purpose for processing is in compliance with the above rules, where this is required or permitted by law.
